

Ergobaby’s “#HomeInMyErgo Photo Contest” (“Promotion”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY REQUIREMENTS:

Ergobaby’s “#HomeInMyErgo Photo Contest” (the “Promotion”). Employees, contractors, officers and directors of The ERGO Baby Carrier, Inc. (“Sponsor”), and its parents, subsidiaries and affiliated companies, distributors and retailers (collectively, with Sponsor, the “Promotion Parties”), and the immediate family members of each (spouse, parents and siblings) and those living in the same households of each are not eligible to participate. 3. Tag @Ergobaby
4. Tell us the story behind the photo and the carrier in your caption. How has babywearing helped you at home?
5. Photos must feature any [Ergobaby baby carrier](#) or [Aura Baby Wrap](#).
6. By tagging your photos with #HomeInMyErgo, your photo is automatically entered and you agree to these official rules.

Only fully completed entries are eligible. Incomplete and/or inaccurate entries are void. Once submitted, all entries become the exclusive property of Sponsor and will not be acknowledged nor returned.

3. SUBMISSION GUIDELINES:

All contents of entries, including but not limited to, video, content, text, images, graphics, photographs, captions and descriptions, hereinafter referred to as (“Submission” or collectively referred to as “Submissions”), must be completely original to entrant and must not have been taken or composed, in whole or in part, from any other source other than entrant, and must have been created specifically for the Contest. All Submission materials become the sole and exclusive property of Sponsor. Submissions will not be returned and receipt of Submissions will not be acknowledged.

Each entrant acknowledges that other entrants may have used ideas and/or concepts in their Submission that may be similar in idea or concept to what is included in entrant's Submission. Each entrant understands and agrees that he/she shall not have any claim against any other entrant or Sponsor arising out any such similarity or be entitled to any compensation because of any such similarity.

Each entrant acknowledges that The ERGO Baby Carrier, Inc. reserves the exclusive right to determine in its sole discretion whether or not to use any of the Submissions (including the winning Submission), if at all.

4. SELECTION OF WINNER AND AWARDING OF CONTEST PRIZE:

- Photo Contest will run from Sunday March 29, 2020 - Sunday 5/31/2020.
- A photo will be randomly selected each week on Saturday, the winner will be notified via DM on IG or email provided

You are only eligible to win once. The potential Contest winner will be notified via Instagram handle Direct Message, phone number, and/or email address listed on the entry form, at the Sponsor's sole discretion, on or about June 30, 2020 and will be required to confirm his/her mailing address for prize and/or paperwork delivery. If a potential Contest winner does not confirm his/her address within five (5) days of initial contact, Sponsor may award prize to an alternate potential Contest winner. A potential Contest winner may be required to sign and return an Affidavit/Declaration of Eligibility and Liability Release, and where legal, a Publicity Release, as well as an IRS W-9 form (i.e. Request for Taxpayer Identification Number and Certification), or other government-issued proof of identification where applicable, each of which, if issued, must be completed, signed and returned within five (5) business days from date of issuance, or the prize may be forfeited and awarded to an alternate winner. If for any reason the Internet portion of the program is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion.
